Rating Action: Moody's assigns A1 to City of Starkville, MS's GO Bonds

New York, March 27, 2024 -- Moody's Ratings has assigned an A1 rating to the City of Starkville, MS's General Obligation Public Improvement Bonds, Series 2024 (Parks and Recreation Improvements Project) and the General Obligation Public Improvement Bonds, Series 2024 (Street Improvements Project). The bonds have anticipated par values of \$13 million and \$5 million respectively. We also maintain an A1 issuer rating and A1 rating on Starkville's outstanding general obligation bonds. Following the current sale, the city will have approximately \$87 million of outstanding debt.

RATINGS RATIONALE

The City of Starkville's A1 rating reflects a moderately sized economy with well below average resident income that will remain stable. This characteristic is counterbalanced by the presence of Mississippi State University, which is a critical anchor of the local economy. The rating is also driven by the city's financial position that will remain consistent despite low cash and reserve ratios relative to the national median for A-rated city and counties. Starkville's leverage profile is a mild credit positive with modest long term liabilities and annual fixed costs that are below the sector median.

The city's general obligation bonds are rated at the same level as the issuer rating because the bonds are backed by an annual ad valorem tax, levied against all taxable property in the city without legal limitation as to rate or amount.

RATING OUTLOOK

Moody's does not assign outlooks to local government issuers with this amount of debt outstanding.

FACTORS THAT COULD LEAD TO AN UPGRADE OF THE RATINGS

- Significantly improved resident income to a level closer the 85% sector median
- Sustained operating surpluses resulting in reserve and cash balanced nearer to 40%

FACTORS THAT COULD LEAD TO A DOWNGRADE OF THE RATINGS

- Materially weakened economy driving resident income or full value below current levels
- Deterioration of cash and reserve ratios below 20%

LEGAL SECURITY

The general obligation bonds are secured by an annual ad valorem tax, levied against all taxable property in the city without legal limitation as to rate or amount.

However, the city expects to pay the majority of the Series A debt service with proceeds of the special sales taxes approved by the voters of the City, including 1% of the gross sales of hotel rooms in the City and 1% of the gross sales of prepared food and beverages (including alcoholic beverages) in the City.

The city expects to pay the Series B bonds from the portion of sales and use taxes collected by the State of Mississippi and diverted to the City semiannually,

USE OF PROCEEDS

Proceeds of the Parks and Recreation Improvements Project Bonds will primarily be used for construction of a community center, improving playground facilities and improving drainage systems in the parks.

Proceeds of the Street Improvements Project Bonds will be used for street paving projects throughout the City.

PROFILE

The City of Starkville is located approximately 125 miles northeast of the City of Jackson (Baa3 stable) and 165 miles southeast of the City of Memphis, Tennessee (Aa2 stable). The city's economy is largely based in manufacturing and retail and benefits from the presence of a major university. The city's estimated population is approximately 24,000.
