NOTICE IS HEREBY GIVEN that combined electronic bids only will be received by the City of Columbia, Tennessee (the "Municipality") for the purchase of all, but not less than all, of its \$72,980,000* General Obligation Capital Improvement Bonds, Series 2024 Bonds (the "Series 2024 Bonds") at the time specified below:

Electronic Bids:	Must be submitted through PARITY® as described below. No other form of bid or provider of electronic bidding services will be accepted.

A single bid for the Bonds will be received until 10:15 a.m., CDT, on Tuesday, August 6, 2024 (or at such later times and date announced at least forty-eight hours in advance via IPREO's PARITY® system). Electronic bids must be submitted for the Series 2024 Bonds through PARITY® as described herein and no other provider of electronic bidding services will be accepted. No written bids will be received. The Municipality's "Preliminary Official Statement", dated July 24, 2024 is an integral part of this "Official Notice of Sale" and is incorporated by reference herein. See "Bidding Instructions" herein.

Description of the Series 2024 Bonds. The Series 2024 Bonds will be issued in fully registered, book-entry form (except as set forth herein) without coupons and will be initially issued or reissued upon transfer in \$5,000 denominations or multiples thereof, as shall be requested by the purchaser or registered owner thereof, as applicable. Interest on the Series 2024 Bonds will be payable on June 1 and December 1 of each year, commencing June 1, 2025.

The Series 2024 Bonds will be dated the date of their issuance expected to be on or about August 22, 2024*. The Series 2024 Bonds will mature and be payable on each year as outlined in the section entitled "Preliminary Amortization Schedules" herein.

Registration and Depository Participation. The Series 2024 Bonds, when issued, will be registered in the name of Cede & Co., DTC's partnership nominee. When the Series 2024 Bonds are issued, ownership interests will be available to purchasers only through a book-entry system maintained by DTC (the "Book-Entry-Only System"). One or more fully-registered Series 2024 Bond certificates will be issued for each maturity, in the entire aggregate principal amount of the Series 2024 Bonds and will be deposited with DTC. The book-entry system will evidence beneficial ownership interests of the Series 2024 Bonds in the principal amount of \$5,000 for the

Series 2024 Bonds and any integral multiple of \$5,000, with transfers of beneficial ownership interest effected on the records of DTC participants and, if necessary, in turn by DTC pursuant to rules and procedures established by DTC and its participants. The successful bidder, as a condition to delivery of the Series 2024 Bonds, shall be required to deposit the Series 2024 Bond certificates with DTC, registered in the name of Cede & Co., nominee of DTC. The Series 2024 Bonds will be payable, at maturity to DTC or its nominee as registered owner of the Series 2024 Bonds. Transfer of principal and interest payments to participants of DTC will be the responsibility of DTC, and transfer of principal and interest payments (as applicable) to beneficial owners of the Series 2024 Bonds by Participants of DTC, will be the responsibility of such participants and of the nominees of beneficial owners. The Municipality will not be responsible or liable for such transfer of payments or for maintaining, supervising or reviewing the records maintained by DTC, its participants or persons acting through such participants.

In the event that the book-entry only system for the Series 2024 Bonds is discontinued and a successor securities depository is not appointed by the Municipality, Series 2024 Bond Certificates in fully registered form will be delivered to, and registered in the names of, the DTC Participants or such other persons as such DTC participants may specify (which may be the indirect participants or beneficial owners), in authorized denominations of \$5,000 for the Series 2024 Bonds or integral multiples thereof. The ownership of Series 2024 Bonds so delivered shall be registered in registration books to be kept by the Registration Agent (named herein) at its corporate trust office, and the Municipality and the Registration Agent shall be entitled to treat the registered owners of the Series 2024 Bonds, as their names appear in such registration books as of the appropriate dates, as the owners thereof for all purposes described herein and in the Resolution (as defined in the "Preliminary Official Statement" which is incorporated herein as an integral part of this "Official Notice of Sale") authorizing the Series 2024 Bonds.

Purpose. The Series 2024 Bonds are being issued for the purpose of providing funds to (i) the construction and equipping of a new wastewater treatment plant and other wastewater system improvements; (ii) the acquisition of all property real and personal appurtenant to any of the foregoing; (iii) payment of all legal, fiscal, administrative, planning, architectural and engineering costs incident thereto. See the section entitled "SECURITIES OFFERED – Authority and Purpose" for additional information.

Security. The Bonds are payable from unlimited ad valorem taxes to be levied on all taxable property within the corporate limits of the Municipality. For the prompt payment of principal of and interest on the Bonds, the full faith and credit of the Municipality is irrevocably pledged.

Optional Redemption. The Series 2024 Bonds shall be subject to redemption prior to maturity at the option of the Municipality on December 1, 2032 and thereafter, as a whole or in part at any time at the redemption price of par plus accrued interest to the redemption date.

Term Bond Option; Mandatory Redemption. Bidders shall have the option to designate certain consecutive serial maturities of the Series 2024 Bonds as term bonds ("Term Bonds") bearing a single interest rate or yield. If the successful bidder for the Series 2024 Bonds designates certain consecutive serial maturities of the Series 2024 Bonds to be combined as one or more Term Bond as allowed herein, then such Term Bond(s) shall be subject to mandatory sinking fund redemption by the Municipality at a redemption price equal to 100% of the principal amount thereof, together with accrued interest to the date fixed for redemption at the rate stated in such Term Bond to be redeemed. Each such mandatory sinking fund redemption shall be made on the date on which a

consecutive maturity included as part of a Term Bond is payable in accordance with the proposal of the successful bidder for the Series 2024 Bonds and in the amount of the maturing principal installment for the Series 2024 Bonds listed herein for such principal payment date. Term Bonds to be redeemed within a single maturity shall be selected in the manner provided for optional redemption of the Series 2024 Bonds within a single maturity.

Bidding Instructions. Electronic bids only for the Series 2024 Bonds must be submitted through IPREO's PARITY® system and no other provider of electronic bidding services will be accepted and no written bids will be accepted. Subscription to the IPREO's PARITY® competitive bidding system is required in order to submit electronic bids. The Municipality will neither confirm any subscription nor be responsible for the failure of any prospective bidders to subscribe. For the purposes of the bidding process, the time as maintained by PARITY® shall constitute the official time with respect to all bids for the Series 2024 Bonds. To the extent any instructions or directions set forth in PARITY® conflict with the terms of the "Official Notice of Sale", this "Official Notice of Sale" shall prevail. Electronic bids made through the facilities of PARITY® shall be deemed an offer to purchase in response to the "Official Notice of Sale" and shall be binding upon each bidder as if made by a signed, sealed written bid delivered to the Municipality. The Municipality, Bond Counsel and the Municipal Advisor shall not be responsible for any malfunction or mistake made by or as a result of the use of the electronic bidding facilities provided and maintained by IPREO. The use of the IPREO's PARITY® facilities is at the sole risk of the prospective bidders. Further information regarding PARITY® may be obtained from IPREO (www.newissuehome.i-deal.com).

Adjustment and/or Revision. While it is the Municipality's intention to sell and issue the approximate par amounts of the Series 2024 Bonds as offered herein, adjustments and/or revisions may be necessary in order to properly size the Series 2024 Bonds. Accordingly, the Municipality reserves the right to make corresponding adjustments in each maturity of the Series 2024 Bonds as described in the following paragraphs.

The Municipality reserves the right in its sole discretion to cancel one or more maturities in their entirety and/or adjust the original par amount of each maturity without limitation. In no case will the par amount of the Series 2024 Bonds exceed \$80,000,000.

Among other factors, the Municipality may (but shall be under no obligation to) consider in sizing the par amount of each maturity are the amount of premium bid per maturity, if any, the size of the individual maturities or sinking fund installments, assuring funding needs and certain debt service patterns and/or other preferences of the Municipality.

In the event of any such adjustment and/or revision with respect to the Series 2024 Bonds, no rebidding will be permitted. The underwriter's discount on the Series 2024 Bonds as submitted by the successful bidder shall be held constant. The "underwriter's discount" shall be defined as the difference between the purchase price of the Series 2024 Bonds submitted and the price at which the Series 2024 Bonds will be issued to the public, as calculated from information provided by the

successful bidder, divided by the par amount of the successful bid for the Series 2024 Bonds.

Notwithstanding the paragraph above, prior to the sale, the Municipality will make a decision on whether to adjust the amortization schedule and the par amount of each maturity of the Series 2024 Bonds. Unless the market is notified via **IPREO** not later than 12:00 Noon (CDT) on the business day preceding the sale date, the Series 2024 Bonds will be offered as outlined herein, but subject to the foregoing additional adjustments, if necessary.

The successful bidder for the Series 2024 Bonds will be notified not later than 5:00 p.m., CDT, on the sale date of the exact revisions and/or adjustments required, if any.

Award. Unless all bids are rejected, the Series 2024 Bonds will be awarded on an all or none basis on the sale date to the bidder whose bid result in the lowest true interest rate for the Series 2024 Bonds to be calculated as that rate (or yield) that, when used in computing the present worth of all payments of principal and interest on the Series 2024 Bonds (compounded semi-annually from the date of the Series 2024 Bonds that produces an amount equal to the purchase price of the Series 2024 Bonds exclusive of accrued interest, if any. For purposes of calculating the true interest cost, the principal amount of any Term Bond scheduled for mandatory sinking fund redemption as part of the Term Bond shall be treated as a serial maturity in such year for the Series 2024 Bonds. In the event that two or more bidders offer to purchase the Series 2024 Bonds at the same true interest rate, the Chair shall determine (in his sole discretion) which bidder shall be awarded the Series 2024 Bonds.

The Municipality reserves the right to reject all bids for the Series 2024 Bonds and to waive informalities in the bid accepted.

Good Faith Deposit. No good faith check will be required to accompany any bid submitted. The successful bidder shall be required to deliver to the Municipality's Municipal Advisor (wire transfer) the amount of \$200,000 that will secure the faithful performance of the terms of the successful bid. Wire transfers must be received by the Municipal Advisor no later than the close of business on the day following the competitive sale. Detailed wiring instructions are as outlined below:

The good faith deposit shall be applied (without interest) to the purchase price of the Series 2024 Bonds. If the successful bidder should fail to accept or pay for the Series 2024 Bonds when tendered for delivery and payment, the good faith deposit pertaining to such bid will be retained by the Municipality as liquidated damages.

In the event of the failure of the Municipality to deliver the Series 2024 Bonds to the purchasers in accordance with the terms of this “Official Notice of Sale” within 45 days after the date of the

sale, the good faith deposit will be promptly returned to such bidder unless such bidder directs otherwise.

Establishment of Issue Price

General. The winning bidder shall assist the Municipality in establishing the issue price of the Series 2024 Bonds as more fully described herein. All actions to be taken by the Municipality under this “Official Notice of Sale” to establish the issue price of the Series 2024 Bonds may be taken on behalf of the Municipality by its Municipal Advisor and any notice or report to be provided to the Municipality may be provided to the Municipal Advisor.

Anticipated Compliance with Competitive Sale Requirements. The Municipality anticipates that the provisions of Treasury Regulation Section 1.148-1(f)(3)(i) (defining “competitive sale” for purposes of establishing the issue price of the Series 2024 Bonds) will apply to the initial sale of the Series 2024 Bonds (the “competitive sale requirements”) because:

- the Municipality shall disseminate this “Official Notice of Sale” to potential underwriters in a manner that is reasonably designed to reach potential underwriters;
- all bidders shall have an equal opportunity to bid;
- the Municipality expects to receive bids from at least three underwriters of municipal bonds who have established industry reputations for underwriting new issuances of municipal bonds; and
- the Municipality anticipates awarding the sale of the Series 2024 Bonds to the bidder who submits a firm offer to purchase the Series 2024 Bonds at the highest price (or lowest interest cost), as set forth in this “Official Notice of Sale”.

Any bid submitted pursuant to this “Official Notice of Sale” shall be considered a firm offer for the purchase of the Series 2024 Bonds, as specified in the bid.

Municipality Intention to Apply the Hold-the-Offering-Price Rule if Competitive Sale Requirements are Not Met. In the event that the competitive sale requirements are not satisfied with respect to the Series 2024 Bonds, the Municipality intends to treat the initial offering prices of the Series 2024 Bonds to the public as the issue price of such Series 2024 Bonds (the “hold-the-offering-price rule”), in each case applied on a maturity-by-maturity basis (and if different interest rates apply within a maturity, to each separate CUSIP number within that maturity).

Application of the Hold-the-Offering-Price Rule. If the competitive sale requirements are not satisfied, then the successful bidder shall, on behalf of the underwriters participating in the purchase of the Series 2024 Bonds (i) confirm that the underwriters have offered or will offer each maturity of the Series 2024 Bonds to the public on or before the date of award at the offering price or prices (the “initial offering price”), or at the corresponding yield or yields, set forth in the bid submitted by the winning bidder and (ii) agree, on behalf of the underwriters participating in the purchase of the Series 2024 Bonds, that the underwriters will neither offer nor sell unsold Series 2024 Bonds of any maturity to any person at a price that is higher than the initial offering price to the public during the period starting on the sale date and ending on the earlier of the following:

- the close of the fifth (5th) business day after the sale date; or

- the date on which the underwriters have sold at least 10% of that maturity of the Series 2024 Bonds to the public at a price that is no higher than the initial offering price to the public.

The winning bidder shall promptly advise the Municipality when the underwriters have sold 10% of that maturity of the Series 2024 Bonds to the public at a price that is no higher than the initial offering price to the public, if that occurs prior to the close of the fifth (5th) business day after the sale date.

By submitting a bid, each bidder confirms that: (i) any agreement among underwriters, any selling group agreement and each retail distribution agreement (to which the bidder is a party) relating to the initial sale of the Series 2024 Bonds to the public, together with the related pricing wires, contains or will contain language obligating each underwriter, each dealer who is a member of the selling group, and each broker-dealer that is a party to such retail distribution agreement, as applicable, to (A) report the prices at which it sells to the public the unsold Series 2024 Bonds of each maturity allotted to it until it is notified by the winning bidder that either the 10% test has been satisfied as to the Series 2024 Bonds of that maturity or all Series 2024 Bonds of that maturity have been sold to the public and (B) comply with the hold-the-offering-price rule if and for so long as directed by the winning bidder and as set forth in the related pricing wires, and (ii) any agreement among underwriters relating to the initial sale of the Series 2024 Bonds to the public, together with the related pricing wires, contains or will contain language obligating each underwriter that is a party to a retail distribution agreement to be employed in connection with the initial sale of the Series 2024 Bonds to the public to require each broker-dealer that is a party to such retail distribution agreement to (A) report the prices at which it sells to the public the unsold Series 2024 Bonds of each maturity allotted to it until it is notified by the winning bidder or such underwriter that either the 10% test has been satisfied as to the Series 2024 Bonds of that maturity or all Series 2024 Bonds of that maturity have been sold to the public and (B) comply with the hold-the-offering-price rule, in each case if and for so long as directed by the winning bidder or such underwriter and as set forth in the related pricing wires.

The Municipality acknowledges that, in making the agreements and representations set forth above, the winning bidder will rely on (i) the agreement of each underwriter to comply with the hold-the-offering-price rule, as set forth in an agreement among underwriters and the related pricing wires, (ii) in the event a selling group has been created in connection with the initial sale of the Series 2024 Bonds to the public, the agreement of each dealer who is a member of the selling group to comply with the hold-the-offering-price rule, as set forth in a selling group agreement and the related pricing wires, and (iii) in the event that an underwriter is a party to a retail distribution agreement that was employed in connection with the initial sale of the Series 2024 Bonds to the public, the agreement of each broker-dealer that is a party to such agreement to comply with the hold-the-offering-price rule, as set forth in the retail distribution agreement and the related pricing wires. The Municipality further acknowledges that each underwriter shall be solely liable for its failure to comply with its agreement regarding the hold-the-offering-price rule and that no underwriter shall be liable for the failure of any other underwriter, or of any dealer who is a member of a selling group, or of any broker-dealer that is a party to a retail distribution agreement to comply with its corresponding agreement regarding the hold-the-offering-price rule as applicable to the Series 2024 Bonds.

Definitions. Sales of any Series 2024 Bonds to any person that is a related party to an underwriter shall not constitute sales to the public for purposes of this “Official Notice of Sale”. Further, for purposes of this “Official Notice of Sale”:

- “public” means any person other than an underwriter or a related party,
- “underwriter” means (A) any person that agrees pursuant to a written contract with the Municipality (or with the lead underwriter to form an underwriting syndicate) to participate in the initial sale of the Series 2024 Bonds to the public and (B) any person that agrees pursuant to a written contract directly or indirectly with a person described in clause (A) to participate in the initial sale of the Series 2024 Bonds to the public (including a member of a selling group or a party to a retail distribution agreement participating in the initial sale of the Series 2024 Bonds to the public),
- a purchaser of any of the Series 2024 Bonds is a “related party” to an underwriter if the underwriter and the purchaser are subject, directly or indirectly, to (i) at least 50% common ownership of the voting power or the total value of their stock, if both entities are corporations (including direct ownership by one corporation of another), (ii) more than 50% common ownership of their capital interests or profits interests, if both entities are partnerships (including direct ownership by one partnership of another), or (iii) more than 50% common ownership of the value of the outstanding stock of the corporation or the capital interests or profit interests of the partnership, as applicable, if one entity is a corporation and the other entity is a partnership (including direct ownership of the applicable stock or interests by one entity of the other), and
- “sale date” means the date that the Series 2024 Bonds are awarded by the Municipality to the winning bidder.

Issue Price Certificate. The winning bidder will be required to provide the Municipality, at closing, with an issue price certificate consistent with the foregoing. A form of the issue price certificate is attached to this “Official Notice of Sale” as Exhibit A. In the event the winning bidder will not reoffer any maturity of the Series 2024 Bonds for sale to the Public (as defined herein) by the delivery date of the Series 2024 Bonds, the issue price certificate may be modified in a manner approved by the Municipality and Bond Counsel.

Legal Opinion. The unqualified approving opinion of Bass Berry & Sims PLC, Nashville, Tennessee, Bond Counsel along with other certificates including, but not limited to, a tax certificate (with respect to the Series 2024 Bonds) and a continuing disclosure certificate dated as of the date of delivery of the Series 2024 Bonds will be furnished to the purchasers at the expense of the Municipality. As set forth in the “Preliminary Official Statement”, Bond Counsel's opinion with respect to the Series 2024 Bonds will state that interest on the Series 2024 Bonds will be excluded from gross income for federal income tax purposes and is not an item of tax preference for purposes of the federal law alternative minimum tax, except as described in the Official Statement. As set forth in the “Preliminary Official Statement”, the owners of the Series 2024 Bonds, however, may be subject to certain additional taxes or tax consequences arising with respect to ownership of the Series 2024 Bonds. Reference is hereby made to the “Preliminary Official Statement” and the proposed form of the opinion which is contained in Appendix A thereof.

Continuing Disclosure. At the time the Series 2024 Bonds are delivered, the Municipality will execute a Continuing Disclosure Certificate(s) in which it will covenant for the benefit of holders

and beneficial owners of the Series 2024 Bonds to provide certain financial information relating to the Municipality by not later than 12 months after each of the Municipality's fiscal years (the "Annual Report"), and to provide notice of the occurrence of certain enumerated events. The Annual Report (and audited financial statements, if filed separately) will be filed with the Municipal Securities Rulemaking Board ("MSRB") through the operation of the Electronic Municipal Market Access system ("EMMA") and any State Information Depository established in the State of Tennessee (the "SID"). If the Municipality is unable to provide the Annual Report to the MSRB and the SID by the date required, notice of each failure will be sent to the MSRB and the SID on or before such date. The notices of certain enumerated events will be filed by the Municipality with the MSRB and the SID. The specific nature of the information to be contained in the Annual Report or the notices of events will be summarized in the Municipality's "Official Statement" to be prepared and distributed in connection with the sale of the Series 2024 Bonds. Reference is hereby made to the "Preliminary Official Statement" ("MISCELLANEOUS – Continuing Disclosure") and the form of the certificate which is contained in Appendix C: "Form of Continuing Disclosure Certificate".

Delivery of Series 2024 Bonds. Delivery of the Series 2024 Bonds is expected on or about August 22, 2024* although that date is subject to change and will be finalized when the Series 2024 Bonds are awarded. At least a 5 day notice will be given to the successful bidder. Delivery will be made in book-entry form through the facilities of The Depository Trust Company, New York, New York. Payment for the Series 2024 Bonds must be made in Federal Funds or other immediately available funds.

CUSIP Numbers. CUSIP numbers will be assigned to the Series 2024 Bonds at the expense of the Municipality. The Municipality will assume no obligation for assignment of such numbers or the correctness of such numbers and neither failure to record such numbers on the Series 2024 Bonds nor any error with respect thereto shall constitute cause for failure or refusal by the purchaser thereof to accept delivery of and make payment for the Series 2024 Bonds.

Provision of Information for the "Official Statement". The successful bidder must furnish the following information to the Municipality to complete the "Official Statement" in final form within 2 hours after receipt and award of the bids for the Series 2024 Bonds:

1. The initial offering prices or yields for the Series 2024 Bonds (expressed as a price or yield per maturity, exclusive of any accrued interest, if applicable);
2. Selling compensation (aggregate total anticipated compensation to the underwriters expressed in dollars, based on the expectation that all the Series 2024 Bonds are sold at the prices or yields as provided above);
3. The identity of the underwriters if the successful bidders are part of a group or syndicate; and
4. Any other material information necessary (including, but limited to, information regarding any bond insurance included as part of the successful bid) to complete the "Official Statement" in final form, but not known to the Municipality.

Official Statements; Other. The Municipality has deemed the “Preliminary Official Statement” (incorporated herein by reference) to be final as of its date within the meaning of Rule 15c2-12 of the Securities and Exchange Commission (the “Rule”) except for the omission of certain pricing and other information.
