NOTICE OF SALE OF BONDS

In accordance with Title 62, Oklahoma Statutes, 2021, Section 354, as amended, notice is hereby given that the City of Lawton, Oklahoma (“City”), will receive sealed or electronic bids on June 24, 2025 (the “Sale Date”), until 11:00 a.m., local time, as per the official time clock of the City Clerk of the City (“City Clerk”), at the City Clerk’s office at 212 S.W. 9th Street, Lawton, Oklahoma, for the sale of \$3,150,000 General Obligation Bonds, Series 2025, dated August 1, 2025, of said City, which shall become due in the amount of \$350,000 on December 1, 2027, \$350,000 on December 1, 2028, \$350,000 on December 1, 2029, \$350,000 on December 1, 2030, \$350,000 on December 1, 2031, \$350,000 on December 1, 2032, \$350,000 on December 1, 2033, \$350,000 on December 1, 2034, and \$350,000 on December 1, 2035.

The General Obligation Bonds, Series 2025 (the “Bonds”) are not subject to redemption prior to maturity.

Bids filed with the City Clerk shall be opened and read in the City Clerk’s Office at 11:00 a.m., local time, on the Sale Date stated above and shall be read in the City Hall Council Chambers at 6:00 p.m., local time, as per the official time clock of the City Clerk and shall be awarded thereafter on said Sale Date by the City Council of the City of Lawton, Oklahoma in the City Hall Council Chambers, 212 S.W. 9th Street, Lawton, Oklahoma. Bids received after 11:00 a.m., local time, as per the official time clock of the City Clerk, on the above-mentioned Sale Date will not be accepted and will be returned to the bidder unopened. There will be no exceptions to this policy.

Pursuant to Okla. Stat. tit. 74, § 12005, each bidder must certify in writing that the bidder does not boycott energy companies and will not boycott energy companies during the term of the bid. “Boycott energy companies” means, without an ordinary business purpose, refusing to deal with, terminating business activity with, or otherwise taking any action that is intended to penalize, inflict economic harm on, or limit commercial relations with a company because the company (i) engages in the exploration, production, utilization, transportation, sale, or manufacturing of fossil-fuel-based energy and does not commit or pledge to meet environmental standards beyond applicable federal and state law, or (ii) does business with a company described by subparagraph (i) of this paragraph. Bids that cannot meet these requirements or do not contain this certification will not be accepted.

The Bonds shall be sold to the bidder bidding the lowest interest cost which the Bonds shall bear and agreeing to pay par and accrued interest for the Bonds. Each bidder shall submit with its bid a sum in cash, cashier’s check, or electronic (wire) transfer payable to the Director of Finance of the City of Lawton, Oklahoma, equal to two percent (2%) of the principal amount of the Bonds. The right is reserved by the City to reject any and all bids and to waive informalities and irregularities.

INSTRUCTIONS TO BIDDERS

Place and Time of Sale

The City of Lawton, Oklahoma (the “City”), will receive sealed bids or electronic bids (**Parity®** or similar secure electronic bids) in the City Clerk’s office at 212 S.W. 9th Street, Lawton, Oklahoma, until 11:00 a.m. local time, as per the official time clock of the City Clerk of the City, on June 24, 2025 (the “Sale Date”), for the sale of the City’s \$3,150,000 General Obligation Bonds, Series 2025 (the “2025 Bonds”), more completely described in the “Official Statement”. The bids will be opened and read in the City Clerk’s office at 11:00 a.m. local time on the Sale Date, and shall be read in the City Hall Council Chambers at 6:00 p.m. local time and awarded thereafter by the City Council in the City Hall Council Chambers, 212 S.W. 9th Street, Lawton, Oklahoma, on the Sale Date.

Bids may be submitted either:

1. In a sealed envelope, plainly marked “Bid for General Obligation Bonds, Series 2025”, addressed to the City Clerk as described below;
2. Via e-mail and telephone to the Financial Advisor; or
3. Electronically via **Parity®** in accordance with this Notice of Sale, until 11:00 a.m. local time, but no bid will be received after the time for receiving bids specified above. To the extent any instructions or directions set forth in **Parity®** conflict with this Notice of Sale, the terms of this Notice of Sale shall control. Subscription to the **Parity®** Competitive Bidding System is required in order to submit a bid electronically. Bidders can contact **Parity®** at (212) 849-5021 to inquire about electronic bidding services. All electronic bids shall be deemed to incorporate the provisions of this Notice of Sale and the Official Bid Form. To bid via **Parity®**, bidders must have made arrangements for the Good Faith Deposit prior to the sale time. For purposes of the electronic bidding process, the time as maintained by **Parity®** shall constitute the official time. The City shall not be responsible for any malfunction or mistake made by or as a result of the use of **Parity®**, the use of such facilities being the sole responsibility of the bidder. In the event of a malfunction in the electronic bidding process, bidders should contact the Financial Advisor to submit a signed Official Bid Form prior to the sale. For information purposes only, bidders are requested to state in their electronic bids the true interest cost to the City, as described under “Award of 2025 Bonds”.

Description of the 2025 Bonds

The 2025 Bonds, authorized at an election held for that purpose, are being issued in accordance with the provisions contained in Article X, Section 27 of the Oklahoma Constitution, and the statutes of the State supplementary thereto, and shall constitute direct and general obligations of the City. Proceeds of the 2025 Bonds will be used to provide funds for the purpose of improving streets and roadways acquired by the City through grant, dedication or otherwise for use by the City’s inhabitants and traveling public, and City-owned utilities under and adjacent to such streets and roadways found to be in need of repair and/or replacement.

The 2025 Bonds will be issued only as full book-entry-only bonds in denominations of \$5,000 or any integral multiples thereof. The 2025 Bonds will be dated August 1, 2025, and shall bear interest from that date. Interest on the 2025 Bonds is payable semiannually on June 1 and December 1, beginning June 1, 2027. Principal and interest on the 2025 Bonds will be payable by the City’s Paying Agent-Registrar bank to the Depository Trust Company, New York, New York (“DTC”), securities depository for the 2025 Bonds (see “Book-Entry-Only System” section below).

The 2025 Bonds are not subject to redemption prior to maturity. **The 2025 Bonds will not be designated as bank qualified obligations.**

Book-Entry-Only System

DTC will act as securities depository for the 2025 Bonds. The 2025 Bonds will be issued as fully registered securities registered in the name of Cede & Co. (DTC’s partnership nominee). One fully registered bond certificate will be issued for each maturity of the 2025 Bonds in the principal amount of such maturity, and will be deposited with DTC at the office of the Trustee on behalf of DTC utilizing the DTC FAST system of registration.

DTC may discontinue providing services as securities depository with respect to the 2025 Bonds at any time by giving reasonable notice to the City. Under such circumstances, in the event that a successor securities depository is not obtained, 2025 Bonds are required to be printed and delivered. The City may

decide to discontinue use of the system of book-entry transfers through DTC (or a successor securities depository). In that event, 2025 Bonds will be printed and delivered.

Types of Bids and Interest Rates

The 2025 Bonds will be sold in one block, all or none, and no bid of less than par and accrued interest shall be considered. **The premium bid, if any, shall not exceed three percent (3%) of the par value of the 2025 Bonds (\$94,500.00).** Bidders shall specify the rates of interest the 2025 Bonds shall bear in multiples of one one-thousandth (1/1000th) of one percent (1%) per annum. Bidders must specify a rate or rates of interest the 2025 Bonds shall bear, **but will be limited to a three percent (3%) variation between high and low interest rates.** No interest rate in excess of ten percent (10%) shall be considered. Bidders are not restricted as to the number of rates that may be named, provided that only one single rate shall be specified for all 2025 Bonds of the same maturity.

Award of 2025 Bonds

The award, if any, will be made to the bidder offering to purchase the 2025 Bonds at the lowest rate of interest which the 2025 Bonds shall bear, which shall be the lowest true interest cost to the City and who agrees to pay accrued interest from the date of the 2025 Bonds to the date of delivery computed on a 360-day year basis. The lowest true interest cost will be determined by doubling the semi-annual interest rate necessary to discount the debt service on the 2025 Bonds to the price bid for the 2025 Bonds. The date from which the annual true interest rate will be calculated is August 1, 2025. Each bidder is requested to supply the net interest cost and the true interest cost that the City will pay upon the issue if the bid is accepted. The right is reserved to reject any and all bids and to waive all informalities and irregularities. Issuance and delivery of the 2025 Bonds are subject to the approval of the City Council.

Official Bid Form and Good Faith Deposit

Each bid must be submitted electronically through the approved *Parity*® bidding system or on the “Official Bid Form” attached hereto, without deviation, furnished by the City and which shall be enclosed in a sealed envelope. If the winning bid is submitted electronically via *Parity*®, the winning bidder will be required to fully execute an Official Bid Form prior to delivery of the Bonds.

A Good Faith Deposit (“Deposit”) in the form of a certified or cashier’s check, cash via wire transfer or a Financial Surety Bond in the amount of **\$63,000.00**, which is two percent (2%) of the par value of the 2025 Bonds, payable to “City of Lawton, Oklahoma”, is required for each bid to be considered. **Bidders wishing to wait until after the bid deadline to submit their Deposit are allowed to do so, as long as the Deposit is received by the City prior to the time of the award by the City Council.**

If a Certified or Cashier’s Check is used, no interest will be allowed on such check. All checks submitted by unsuccessful bidders will be promptly returned upon award of the 2025 Bonds.

Wire instructions for the City are available upon request to the Financial Advisor. If a wire transfer is used, the City intends to wire back the Deposits of the losing bidders as soon as possible after the bid deadline. No interest will be paid by the City on the Deposit.

If a Financial Surety Bond is used, it must be issued by an insurance company licensed to issue such a bond in the State of Oklahoma and meeting the minimum qualifications of such providers (i.e., “AAA” rated), and such bond must be submitted to the City or its Financial Advisor prior to the opening of the bids. The Financial Surety Bond must identify each bidder whose Deposit is guaranteed by such Financial Surety Bond. Each Financial Surety Bond shall provide that it will not expire for at least 48 hours from the date and

time of opening the bids. If the 2025 Bonds are awarded to a bidder utilizing a Financial Surety Bond, then that purchaser ("Purchaser") is required to submit its Deposit to the City in the form of a wire transfer not later than 3:30 p.m. local time on the next business day following the award, in accordance with wiring instructions provided by the City or its Financial Advisor. If such Deposit is not received by that time, the Financial Surety Bond may be drawn by the City to satisfy the Deposit requirement. No interest on the Deposit will accrue to the Purchaser.

In the event that the Financial Surety Bond is drawn upon, the City will return such funds to the Purchaser (1) upon payment of the purchase price by the Purchaser, or (2) if the City is unable to deliver the 2025 Bonds in accordance with the terms of this Notice of Sale and Instructions to Bidders, or (3) upon the expiration of the final date by which the City may deliver the 2025 Bonds to the Purchaser as described herein. Any funds received by the City as a result of a draw on a Financial Surety Bond may be invested by the City, but no interest will accrue to the successful bidder as a result of such investment.

The Deposit will be returned to the Purchaser upon payment for the 2025 Bonds or applied to the purchase price. In the event the Purchaser fails to honor its accepted bid, the Deposit will be retained by the City. If the Purchaser should fail to pay for the 2025 Bonds in accordance with its bid, the Deposit will be accepted by the City as full and complete liquidated damages.

CUSIP Numbers

It is anticipated that a CUSIP identification number will be printed on the 2025 Bonds, but neither the failure to print such number on any 2025 Bond nor any error with respect thereto shall constitute cause for a failure or refusal by the purchaser to accept delivery of and pay for the 2025 Bonds in accordance with the terms of the Official Bid Form. All expenses in relation to printing CUSIP numbers on the 2025 Bonds and the CUSIP Service Bureau charge for the assignment of such numbers shall be paid by the City.

Approving Opinion

Bids may be submitted subject to the opinion of the Attorney General of the State of Oklahoma, and the approving opinion of Floyd & Driver, PLLC, Norman, Oklahoma, Bond Counsel, each of which shall be provided by the City, without cost to the purchaser.

Non-Litigation Certificate

With delivery of the 2025 Bonds, the City shall execute and furnish the successful purchaser with a certificate to the effect that no litigation of any nature has been filed or is then pending to restrain or enjoin the issuance or delivery of said 2025 Bonds, to affect the provisions made for their payment or security, or in any manner question the validity of said 2025 Bonds.

Delivery

Delivery of the 2025 Bonds shall be made at the expense of the Purchaser through DTC against payment in good funds of the agreed upon purchase price. Delivery of the 2025 Bonds to the Purchaser is anticipated on or about August 20, 2025.

Municipal Bond Insurance

In the event the 2025 Bonds are qualified for municipal bond insurance, and the purchaser wants to purchase bond insurance, the cost thereof will be paid by the purchaser. Any fees paid to any rating agencies as a result of said insurance will also be paid by the purchaser.

Official Statement

The City has authorized and directed the preparation of the accompanying Preliminary Official Statement, and for the limited purpose of complying with Securities and Exchange Commission (“SEC”) Rule 15c2-12(b)(5)(i) deems such Preliminary Official Statement to be “near final” as of its date, within the meaning of such Rule, for the purpose of review prior to bidding. The Preliminary Official Statement is subject to revision, amendment and completion as the final Official Statement.

The Purchaser shall be responsible for providing the initial reoffering prices and other terms, if any, to the Financial Advisor by the close of the next business day after the sale.

No more than seven (7) business days after the date of the sale, the City will provide without cost to the Purchaser a reasonable number of copies of the Final Official Statement; provided, however, that minor delays in furnishing such Final Official Statement will not be a basis for Purchaser’s failure to pay for and accept delivery of the 2025 Bonds. Additional copies of the Final Official Statement will be made available at the Purchaser’s request and expense.

If the sale of the 2025 Bonds is awarded to a syndicate, the City will designate the Senior Managing Underwriter of the syndicate as its agent for purposes of distributing copies of the Final Official Statement to each participating underwriter. Any underwriter executing and delivering a bid form with respect to the 2025 Bonds agrees thereby that if its bid is accepted, it shall accept such designation and shall enter into a contractual relationship with all syndicate members for the purpose of assuring the receipt and distribution of the Final Official Statement to each such syndicate member. The City assumes no responsibility or obligation for the distribution or delivery of the Final Official Statement to anyone other than the Purchaser.

Continuing Disclosure

The City will execute a Continuing Disclosure Agreement (the “Continuing Disclosure Agreement”) for the benefit of the holders of the 2025 Bonds pursuant to which the City will covenant to provide certain financial information concerning the City as required under Section (b)(5)(i) of SEC Rule 15c2-12. A form of the Continuing Disclosure Agreement is attached to the Preliminary Official Statement, and will also be attached to the Final Official Statement. A certified copy of the Continuing Disclosure Agreement will be delivered to the respective successful bidder at or prior to delivery of the 2025 Bonds.

Compliance with the Energy Discrimination Elimination Act

The City will not award the 2025 Bonds to any bidder unless that bidder verifies on the Official Bid Form that it does not boycott energy companies, and will not boycott energy companies during the term of the contract, to the extent the Official Bid Form represents a contract within the meaning of Oklahoma’s Energy Discrimination Elimination Act of 2022, 74 O.S. 2021 § 12001 *et seq.* This verification applies only to a contract that:

1. is between a governmental entity and a company with ten or more full-time employees, and
2. will pay a company One Hundred Thousand Dollars (\$100,000.00) or more over the term of the contract that is to be paid wholly or partly from public funds of the governmental entity; provided, however, the provisions of this paragraph shall apply separately to all companies in a multiple party contract.

Establishment of Issue Price

The winning bidder shall assist the City in establishing the issue price of the 2025 Bonds and shall execute and deliver to the City prior to closing an “Issue Price Certificate”, or similar certificate, setting forth the reasonably expected initial offering price to the public, if at least three (3) bids are received by the City or, if less than three (3) bids are received, the sales price or prices at which the first 10 percent (10%) of each maturity of the 2025 Bonds is sold to the public, substantially in the form attached hereto, with such modifications as may be appropriate or necessary, in the reasonable judgment of the winning bidder, the City, the Financial Advisor, and Bond Counsel, if applicable.

The City intends that the provisions of Treasury Regulation Section 1.148-1(f)(3)(i) (defining “competitive sale” for purposes of establishing the issue price of the 2025 Bonds) will apply to the initial sale of the 2025 Bonds to the public (the “competitive sale requirements”):

1. the City shall disseminate this Notice of Sale to potential underwriters in a manner that is reasonably designed to reach potential underwriters;
2. all bidders shall have an equal opportunity to bid;
3. the City anticipates receiving bids from at least three (3) underwriters of municipal bonds who have established industry reputations for underwriting new issuances of municipal bonds;
4. the City anticipates awarding the 2025 Bonds to the bidder who submits a firm offer to purchase the 2025 Bonds at the lowest true interest cost, as set forth in this Notice of Sale of Bonds

The City shall take all reasonable steps that are appropriate so that the initial sale of the 2025 Bonds to the public will satisfy the competitive sale requirements.

In the event that the initial sale of the 2025 Bonds to the public does not satisfy the competitive sale requirements, bids will not be subject to cancellation and the City will treat the first price at which 10% of a maturity of the 2025 Bonds (the “10% test”) is sold to the public as the issue price of that maturity.

If the 10% test has not been satisfied as to any maturity of the 2025 Bonds, the winning bidder agrees that, for each maturity of the 2025 Bonds that has not satisfied the 10% test (the “Undersold Maturities”), it will neither offer nor sell any of the Undersold Maturities of such maturity to any person at a price that is higher than the Initial Offering Price for such maturity during the Offering Period for such maturity, nor will it permit a related party to do so. With respect to the Undersold Maturities, the Offering Period is defined as the period starting on the Sale Date and ending on the earlier of (i) the close of the fifth business day after the sale date, or (ii) the date on which the winning bidder has sold 10% of such Undersold Maturity (or Maturities, if applicable) to the public at a price that is no higher than the Initial Offering Price for such Undersold Maturity (or Maturities, if applicable).

By submitting a bid, each bidder confirms that: (i) any agreement among underwriters, any selling group agreement and each retail distribution agreement (to which the winning bidder is a party) relating to the initial sale of the 2025 Bonds to the public, together with the related pricing wires, contains or will contain language obligating each underwriter, each dealer who is a member of the selling group, and each broker-dealer that is a party to such retail distribution agreement, as applicable, to neither offer nor sell any of the Undersold Maturities of such maturity to any person at a price that is higher than the Initial Offering Price for such maturity during the Offering Period for such maturity, nor will it permit a related party to do so, and (ii) any agreement among underwriters relating to the initial sale of the 2025 Bonds to the public, together with the related pricing wires, contains or will contain language obligating each underwriter that

is a party to a retail distribution agreement to be employed in connection with the initial sale of the 2025 Bonds to the public to require each broker-dealer that is a party to such retail distribution agreement to neither offer nor sell any of the Undersold Maturities of such maturity to any person at a price that is higher than the Initial Offering Price for such maturity during the Offering Period for such maturity, nor will it permit a related party to do so.

Sales of said 2025 Bonds to any person that is a related party to an underwriter shall not constitute sales to the public for purposes of this Notice of Sale. Further, for purposes of this Notice of Sale:

1. “public” means any person other than an underwriter or a related party;
2. “underwriter” means (i) any person that agrees pursuant to a written contract with the City (or with the lead underwriter to form an underwriting syndicate) to participate in the initial sale of the 2025 Bonds to the public and (ii) any person that agrees pursuant to a written contract directly or indirectly with a person described in clause (i) of this paragraph to participate in the initial sale of the 2025 Bonds to the public (including a member of a selling group or a party to a retail distribution agreement participating in the initial sale of the 2025 Bonds to the public); and
3. a purchaser of any of the 2025 Bonds is a “related party” to an underwriter if the underwriter and the purchaser are subject, directly or indirectly, to more than 50% common ownership.

In the event the winning bidder will not reoffer the 2025 Bonds for sale to the public, the Issue Price Certificate may be modified in a manner approved by the City.

All action to be taken by the City under this Notice of Sale to establish the issue price of the 2025 Bonds may be taken on behalf of the City by BOK Financial Securities, Inc., acting as the City’s Financial Advisor, and any notice or report to be provided to the City may be provided to BOK Financial Securities, Inc.

NOTE: In the event that the initial sale of the 2025 Bonds to the public does not satisfy the competitive sale requirements as defined above, and the winning bidder informs the Financial Advisor that there exist certain Undersold Maturities, the basis for determining the issue price of the 2025 Bonds may be different from the method described herein and may be determined on the sale date upon approval of the Financial Advisor.

(b) The Underwriter has agreed in writing that, (i) for each Maturity of the Hold-the-Offering-Price Maturities, it would neither offer nor sell any of the unsold 2025 Bonds of such Maturity to any person at a price that is higher than the Initial Offering Price for such Maturity during the Holding Period for such Maturity (the “hold-the-offering-price rule”), and (ii) any selling group agreement shall contain the agreement of each dealer who is a member of the selling group, and any retail distribution agreement shall contain the agreement of each broker-dealer who is a party to the retail distribution agreement, to comply with the hold-the-offering-price rule. Pursuant to such agreement, to the best of our knowledge based on our records, the Underwriter has not offered or sold any unsold 2025 Bonds of any Maturity of the Hold-the-Offering-Price Maturities at a price that is higher than the respective Initial Offering Price for that Maturity of the 2025 Bonds during the Holding Period.

3. ***Defined Terms.***

(a) *General Rule Maturities* means those Maturities of the 2025 Bonds listed in Schedule A hereto as the “General Rule Maturities”.

(b) *Hold-the-Offering-Price Maturities* means those Maturities of the 2025 Bonds listed in Schedule A hereto as the “Hold-the-Offering-Price Maturities”.

(c) *Holding Period* means, with respect to a Hold-the-Offering-Price Maturity, the period starting on the Sale Date and ending on the earlier of (i) the close of the fifth business day after the Sale Date, or (ii) the date on which the Underwriters have sold at least 10% of such Hold-the-Offering-Price Maturity to the Public at prices that are no higher than the Initial Offering Price for such Hold-the-Offering-Price Maturity.

(d) *Issuer* means the City of Lawton, Oklahoma.

(e) *Maturity* means 2025 Bonds with the same credit and payment terms. 2025 Bonds with different maturity dates, or 2025 Bonds with the same maturity date but different stated interest rates, are treated as separate maturities.

(f) *Public* means any person (including an individual, trust, estate, partnership, association, company, or corporation) other than the Underwriter or a Related Party (as such terms are defined below) to an Underwriter.

(g) A purchaser of any of the 2025 Bonds is a *Related Party* to any Underwriter if the Underwriter and the purchaser are subject, directly or indirectly, to (i) at least 50% common ownership of the voting power or the total value of their stock, if both entities are corporations (including direct ownership by one corporation of another), (ii) more than 50% common ownership of their capital interests or profits interests, if both entities are partnerships (including direct ownership by one partnership of another), or (iii) more than 50% common ownership of the value of the outstanding stock of the corporation or the capital interests or profit interests of the partnership, as applicable, if one entity is a corporation and the other entity is a partnership (including direct ownership of the applicable stock or interests by one entity of the other).

(h) *Sale Date* means the first day on which there is a binding contract in writing for the sale of a Maturity of the 2025 Bonds. The Sale Date of the 2025 Bonds is June 24, 2025.

(i) *Underwriter* means (i) any person that agrees pursuant to a written contract with the Issuer (or with the lead underwriter to form an underwriting syndicate) to participate in the initial sale of the 2025 Bonds to the Public, and (ii) any person that agrees pursuant to a written contract directly or indirectly with a person described in clause (i) of this paragraph to participate in the initial sale of the 2025 Bonds to the Public (including a member of a selling group or a party to a retail distribution agreement participating in the initial sale of the 2025 Bonds to the Public).

The representations set forth in this certificate are limited to factual matters only, and as it relates to the actions of the other Underwriters, such representations are made to the best of the Underwriter's knowledge based on the Underwriter's records. Nothing in this certificate represents the Underwriter's interpretation of any laws, including specifically Sections 103 and 148 of the Internal Revenue Code of 1986, as amended, and the Treasury Regulations thereunder. The undersigned understands that the foregoing information will be relied upon by the Issuer with respect to certain of the representations set forth in the Arbitrage and Use of Proceeds Certificate and with respect to compliance with the federal income tax rules affecting the 2025 Bonds, and by Floyd & Driver, PLLC, Norman, Oklahoma, as Bond Counsel to the Issuer, in connection with rendering its opinion that the interest on the 2025 Bonds is excluded from gross income for federal income tax purposes, the preparation of the Internal Revenue Service Form 8038-G, and other federal income tax advice that it may give to the Issuer from time to time relating to the 2025 Bonds.
